When: File on or before January 15 of odd-numbered years, or if appointed after January 15, then within 10 days after the appointment. 3 V.S.A. § 1211(a).

If you filed a 17 V.S.A. § 2414 candidate disclosure form in the preceding year, and your information has not changed since, you must still submit this disclosure form.
